

Applications invited for marriage assistance scheme

Chennai, July 29 Recognizing that the enrolment ratio of girl students from Government schools in higher education is very low and to promote higher education among girls belonging to the economically weaker families, the Moovalur Ramamirtham Ammaiyyar Marriage Assistance scheme shall be transformed as the Moovalur Ramamirtham Ammaiyyar Higher Education Assurance Scheme. All girl students who studied from Classes 6 to 12 in Government schools will be paid Rs.1,000/- per month directly into their bank account till the uninterrupted completion of their undergraduate degree, diploma and ITI courses. The students shall be eligible for this in addition to other scholarships.

Eligibility

- The girl students who have completed their school education from 6th to 12th Standard in Government schools.
- Definition of Government schools should mean and include Government schools, Corporation schools, Municipal schools, Panchayat Union schools, Adi Dravidar and Tribal Welfare schools, Kallar Reclamation schools, Forest Department schools students, schools functioning under

the control of Social Welfare and Women Empowerment department including Service Homes / Government Children Homes.

- Girl students who studied in private schools in Tamil Nadu from 6th to 8th standard through RTE, and if they studied in Government schools from 9th to 12th standard can be benefitted from this scheme.

- Girl students are Eligible to avail incentive amount of Rs.1000 for the first higher education course viz., Arts and Science, Professional courses, Paramedical, Diploma, ITI, combined Post graduation etc only.
- Incentive amount are available for first three years of arts and science course, first four years of engineering courses and first to 5 years of medical studies.
- No incentive will be paid for the internship period.
- Any number of girl children passed out from Government school, from the same family who is pursuing higher education are eligible to avail the incentive.
- This incentive amount will be given to the students who are studying in the College.
- Girl students studying in distance education/un-recognized educational institutions are not eligible under this scheme.

- The students will be eligible for this in addition to other scholarships.

- Students who are already enrolled in higher education can also apply for this scholarship for their remaining years of study.

- A new website (<https://www.pudhumaipeenn.tn.gov.in>) has been developed for the scheme. Students can register under this scheme with the nodal officer of the college where they are pursuing higher education.

Salient Features of this scheme

- By providing financial benefits to the girl students, under this programme negotiates a behavioral change in the area of reduction in higher incidences of early marriage and low ratio of enrolment in higher education, and retention of girl students in higher education.
- Moovalur Ramamirtham Ammaiyyar Higher Education Assurance Scheme therefore envisages empowerment of girls specifically who have passed out from Government schools.
- Promotes girl students educational status and instill motivation to pursue higher education giving them better foundation in both economic and social spheres including improving gender parity

at higher levels.

- ii. Enables the creation and participation of skilled women workforce.

- iii. Incentive benefits of Rs.1,000/- per month per beneficiary, enables girl children to pursue education without incurring additional expenses and hindrances.
- iv. Enable Girl Students to get involved in public spaces and enhance career opportunities.

- vi. Prevents drop outs beyond higher secondary and increase the retention ratio in higher education
