

UltraTech Unit helps rural women economically independent through skill training

Chennai, Feb. 13: UltraTech Cement grinding unit, Arakkonam Cement Works, located in Ranipet district of Tamil Nadu, has through its corporate social responsibility (CSR) initiative helped over 2,000 rural women from marginalised sections of the community. The women in these villages were dependent on unskilled labour, animal husbandry and agriculture to earn their livelihoods. As the work was seasonal and erratic,

Kumpinipet, Melpakkam, Thandalam, Parithiputhur and Chitteri, located in the vicinity of the unit as part of its CSR initiative to help secure sustainable livelihoods for women from marginalised sections of the community. The women in these villages were dependent on unskilled labour, animal husbandry and agriculture to earn their standard of living.

Arakkonam Cement Works unit adopted five villages namely,

the women remained financially dependent. Given the potential of tailoring and embroidery for self-employment as well as employment in the local textile units, the unit CSR team setup a training facility and commenced free tailoring and embroidery training for the women.
