Prague Spring was more than policy

At the centre of this quiet unrest was Antonín Novotný, a rigid apparatchik unable to quell the growing dissatisfaction. Slovak voices, among them Alexander Dubuek, rose against his rule, decrying the dominance of Prague's central authority. In January 1968, the tide shifted. Novotný fell, and in his place emerged Dubuek, a leader who spoke not in the harsh commands of ideology, but in the gentler tones of possibility.

What followed was nothing short of a political springtime. In April, Dubuek unveiled his "Action Programme", a manifesto that cracked open the sealed windows of society. The promises sounded like music to ears long deafened by propaganda: freer elections, liberty of speech and religion, open borders, and economic renewal. Most daring of all, censorship was dismantled, and suddenly the written word, the painted canvas, the stage, and the screen bloomed

with life. Dubuek called it "socialism with a human face." To the people, it felt like socialism with a heartbeat.

The Prague Spring was more than policy; it was a rebirth of spirit. Cafés buzzed with debate late into the night. Students marched not in fear, but in joy. Writers poured truth onto pages without trembling. The nation seemed to awaken from a long winter sleep, and its cultural soul, once buried, danced back into the light.

But joy, in a world divided by the Cold War, was dangerous. In Moscow, Leonid Brezhnev and his Warsaw Pact allies saw the reforms not as renewal, but as contagion. East Germany and Poland, brittle with unrest of their own, feared the virus of freedom might spread across their borders. Brezhnev warned Dubuek, but the Slovak reformer, carried on the shoulders of popular adoration, did not retreat. "Let us create our own path," he urged, confident that history was on his side.

On the night of August 20, 1968, history turned its darkest page. From the east and the north, from Hungary, Poland, and Bulgaria, the iron tide rolled in—nearly 200,000 troops and 2,000 tanks, the largest military intervention in Europe since Hitler's fall. The



roar of engines shattered the stillness of Prague's streets. The city awoke not to freedom, but to occupation.

The people resisted not with weapons, but with wit and courage. Street signs were torn down to bewilder the invaders. Students painted slogans on walls: "Lenin, wake up - Brezhnev has gone mad!" Radio Prague held out for hours, its journalists broadcasting the heartbeat of resistance until soldiers silenced them with bullets - 20 fell defending a transmitter. Yet the voices of defiance scattered across the land, transmitted from hidden stations until they too were crushed.

Dubuek and his companions were dragged to Moscow, their dream smothered. In the streets, protesters faced tanks with bare hands; more

than a hundred were killed. The world watched, horrified but unmoved condemnations without action. And as the smoke cleared, thousands of Czechoslovakia's brightest minds fled westward, leaving behind a silence heavier than before.

The Prague Spring lasted but eight months, a brief flowering crushed beneath steel tracks. Yet its fragrance lingered, an eternal reminder that even when armies occupy a land, they cannot conquer the human desire for freedom.

Raturaj ton helps Maharashtra post 440 in first knock

Chennai, Aug 27: Five centuries, a seven wicket haul, and three five wicket hauls marked opening day's highlights in the third and final round of Group league matches in the All India Bhubaneswar cricket tournament being held at various venues here today.

Star cricketer and IPL CSK skipper No.3 batter Raturaj Gaikwad scored a sterling 133 and opener Arshin Kulkarni struck 146 to help Maharashtra amass 440 in 90 overs in their first innings against Himachal Pradesh, while Jharkhand opener Shikhar Mohanhit a brilliant 105 to guide his team to 366 for 8.

In other matches, Sarfaraz Khan' run-a-ball formed the cornerstone as Mumbai scored 346 for nine against Haryana

despite a six wicket haul by offie Nikhil Kashyap (6 for 80) and Rajesh Dhupar of Odisha scored 104 in the team's total of 314 all out against Jammu and Kashmir.

On the bowling front, left arm spinner Priene Thakur returned with a rich haul of seven wickets for Himachal Pradesh against Maharashtra.

The fifers were recorded by Rahul Prasad (Bengal) 5 for 44 vs TNCA XI, Shashank Tiwari (Chhattisgarh) 5 for 54 against TNCA President's XI and Rohit Rayudu (Hyderabad) 5 for 44 helped his team bowl out Madhya Pradesh for 181 in 56.5 overs.

"Oh, don't worry," replies India breezily, "that's not an export—it's scrap. We don't need it anymore."

And imagine the duty invoice: Hate: Zero tariff.

Hypocrisy: Zero tariff.

Intolerance: Zero tariff.

But for mango pickle? Twenty-five dollars extra, please!

Isn't it strange, dear reader, that the things the world actually respects us for—our music, our films, our ideas, our tolerance—are slowly being taxed out of existence, while what should have been banned at the border is exported freely, gleefully, triumphantly?

Yes, India may one day be Vishwaguru, but at this rate, our gurukul syllabus will teach the world how to silence dissent, demonize difference, and distribute hate like free prasad.

So next time I stand at an airport counter and declare my tiny treasures of food, I think of my country's big consignments passing through international scanners. And I pray that one day, when the world reads "Made in India," it will smell not of hate and hypocrisy but of hope, harmony, and healing, it did once, when Gandhiji exported non-violence to the rest of the world.

But till that happens again, welcome to the only nation where mango pickle is charged and our hypocrisies travel free...!

Pragg, Caruana in joint lead with one round to go

Grand Masters Pragganandhaa and Caruana lead the Sinquefeld Cup race with just one round to go. Both logged in a 5/8 score, as lead positions remained unchanged after the 8th and penultimate round of the Grand Chess Tour's Sinquefeld Cup at the University Club Tower, Richmond Heights, Missouri, USA. Following the leading duo were American GMs Wesley So & Levon Aronian at 4.5 points each.

Pragg continued to play up to his strength holding American Wesley So to a comfortable draw. Employing Italian game two knights defence Pragg indicated his intentions to fight with a safe and solid opening set up. But periodical trade-offs moved the game quickly into a rook and knight ending. By the 44th move the players were happy to go in for a three fold repetition. The viewers in the end got an error free game from both the Grandmasters when the draw was a fair result.

Former world rapid champion Nodirbek Abdusattorov redeemed himself scoring his first victory of the Sinquefeld

Cup defeating Iranian-French GM Alireza Firouzja. Despite being shoved to the bottom of the points table, it was Abdusattorov who refused to be drawn into a quick draw. "This is (the) principle. I don't make quick draws," said Abdusattorov on going ahead with the game declining a threefold repetition. He further felt that he's going through the most difficult tournament of his career and intends to come out stronger. The King's Indian Defense Fianchetto Variation appeared coasting to an even middle-game. It was then Firouzja slipped with 21...Nd7? giving away two minor pieces for a rook. Just when black was hanging on to his precious life, Firouzja strangely decided to give up his rook for the bishop, getting an improbable win. From that moment, Abdusattorov played out with great precision, sewing up the game after 60 moves.

The Sinquefeld Cup 2025 carries a prize fund of \$350,000 along with GCT circuit points leading up to the GCT grand finals to be held at Sao Paulo, Brazil next month. Handsome

cash prizes along with qualification for the GCT grand finals are bound to make the final day's play a close affair. Frenchman Maxime Vachier-Lagrave is the first one secure his place for the GCT grand finals, while GMs Caruana, Pragganandhaa, Aronian and Wesley So have chances to lock in the other three qualification spots.

World Champion Gukesh Dommaraju survived a possible defeat when Aronian missed a possible win a little before the game was drawn. Games between Seviaan vs Duda, MVL - Caruana ended

in draws. The 9th & final round starts today by 11 p.m. IST.
