Electronic Voting Machines used in the 2026 Assembly General Elections were sealed and secured in the strong room at Arignar Anna Engineering College, Ponnerikkarai, under the supervision of Election General Observer Abhay Singh, and District Election Officer/ Kancheepuram Collector Sneha, in the presence of representatives of all political parties and senior officials.

## EVMs sealed in strong rooms under tight security

Tiruvallur, Apr 25: Electronic Voting Machines (EVMs) used in the 2026 Assembly General Elections were securely sealed and placed in strong rooms across 10 Assembly constituencies on April 24, following the completion of polling. The process was conducted under the supervision of Election General Observers and District Election Officer/Tiruvallur Collector M. Pratap, who personally inspected the arrangements to ensure transparency and adherence to prescribed guidelines.

At the Government Industrial Training Institute in Sevvapat, EVMs from Gummidipoondi, Ponneri, Tiruttani and Tiruvallur constituencies-covering 344, 327,

337 and 335 polling stations respectively-were sealed in strong rooms in the presence of representatives of recognized political parties. Similarly, at a private educational institution campus in Perumalpet, officials oversaw the sealing of EVMs from Avadi, Maduravoyal and Tiruvottiyur constituencies, which accounted for 502, 484 and 344 polling stations respectively.

In continuation, at a technical college campus in Perumalpet, EVMs from Poonamallee, Ambattur and Madhavaram constituencies, covering 452, 365 and 526 polling stations respectively, were also securely placed and sealed. The entire exercise was carried

out in accordance with Election Commission norms, ensuring that all machines were stored safely in strong rooms and sealed in the presence of authorized political party agents to maintain credibility and transparency.

Senior officials, including Election Observers Devendra Singh Kushwaha, Mohamed Akbar Wani, Vanlal Mavia, Rakhi Biswas, and Prabal Sepfa, participated in the inspections along with district-level officers and election staff. Authorities confirmed that robust, multi-layered security arrangements have been put in place at all strong room locations and will remain in force until the completion of vote counting.

## Madras University offers free education to underprivileged students

Chennai, Apr 25: In a significant move to bridge the educational divide, the University of Madras has officially opened applications for its "Madras University Free Education Scheme" for the academic year 2026-2027. The initiative, which has been active since 2010, aims to ensure that financial constraints do not hinder the academic dreams of bright, underprivileged students in Tamil Nadu.

The program specifically targets those who have completed their Plus-Two (Class 12) examinations in the 2025-2026 academic year, offering them a chance to pursue Undergraduate (UG) degree programmes in aided and self-financing colleges affiliated with the University.

The scheme is strictly designed for

those in genuine need. To qualify, the annual family income must not exceed Rs.3,00,000. Beyond financial status, the University has outlined a preference hierarchy to support the most vulnerable sections of society:

Economically Backward Students, Orphans and Children of Widows/Widowers, First-Generation Graduates (the first in their family to pursue a degree) Transgender Students.

Prospective students must act quickly. The university has mandated a strict timeline for the digital-only application process:

Application Mode: Online only via the official website (www.unom.ac.in). Applications must be uploaded within 15 days from the publication of the Plus-Two results. Requirement: All necessary

documents and scanned copies must be duly uploaded; physical submissions or incomplete online forms will not be accepted.

By prioritizing orphans, first-generation learners, and the transgender community, Madras University continues to use this scheme as a tool for social engineering and inclusion. For many students who would otherwise enter the workforce immediately after school due to poverty, this scheme offers a pathway to professional stability and social mobility.

Note to Applicants: Ensure all income certificates and community documents are updated and ready for scanning to meet the tight 15-day window following result declarations.

## Drone ban imposed around strong room

Ranipet, Apr 25: A drone ban has been enforced within a 3-kilometre radius of the EVM strong room following the completion of polling, with the machines from four constituencies now secured under tight protection.

The EVMs have been

placed at the counting centre located in Arignar Anna Government Women's Arts and Science College, where a three-tier security system has been established to ensure their safety and integrity.

According to District Election Officer and Ranipet Collector J.U. Chandrakala, the area surrounding the strong room has been declared a "Red Zone" from April 23 to May 5.

As part of heightened security measures, the operation of drones and Remotely Piloted Aircraft Systems (RPAS) has been strictly prohibited within this restricted zone until all election-related processes, including vote

counting, are completed.

Officials stated that these measures have been implemented to maintain strict surveillance and prevent any unauthorized activities near the strong room, ensuring a free and fair election process.
